

VILLAGE OF WOODLAND RESIDENT

THESE ARE THE MOST COMMON ORDINANCES BUT NOT LIMITED TO:

- ❖ THE VILLAGE OF WOODLAND COUNCIL IS REMINDING PROPERTY OWNERS AND RESIDENTS THAT LONG GRASS AND WEEDS IN THE VILLAGE MUST BE MAINTAINED ACCORDING TO THE VILLAGE ORDINANCE. TALL GRASS INVITES VERMIN AND PESTS INTO THE AREA AND CAN RESULT IN AN UNPLEASANT ENVIRONMENT. *ORDINANCE #204.14(a)(b)* .
- ❖ YOUR DOGS SHOULD NOT BE RUNNING AT LARGE. THE DOG(S) SHOULD BE LEASHED. YOU ARE RESPONSIBLE TO CLEAN UP AFTER YOUR DOG(S) ON PRIVATE AND PUBLIC PROPERTY. *ORDINANCE #203.4.*
- ❖ THE VILLAGE OF WOODLAND COUNCIL IS REMINDING CAT OWNERS IT IS YOUR RESPONSIBILITY TO KEEP YOUR ANIMAL IN YOUR YARD AND NOT RUN LOOSE ENTERING YOUR NEIGHBORS PROPERTY.
- ❖ NO FARM ANIMALS ALLOWED. IT IS UNLAWFUL TO HARBOR, KEEP OR POSSESS HORSES, PONIES, GOATS, PIGS, COWS, TURKEYS, DUCKS, ETC. OR ANY OTHER FARM DOMESTIC LIVESTOCK OR FOWL. *ORDINANCE #203 SECTION 1.*
- ❖ WHILE BURNING IS ALLOWED, IT IS UNLAWFUL TO BURN RUBBER, PLASTIC, TRASH, GARBAGE, STYROFOAM AND FURNITURE. *ORDINANCE #204.*
- ❖ THE VILLAGE OF WOODLAND COUNCIL IS REMINDING RESIDENTS THAT THERE IS A VILLAGE ORDINANCE IN PLACE THAT PROHIBITS UNOPERABLE/JUNK VEHICLES, ABANDONED AND/OR UNREGISTERED, NOT LICENSED, UNINSURED VEHICLES ON RESIDENT'S PROPERTY. THESE TYPES OF VEHICLES MUST BE REMOVED. *ORDINANCE #204.7.*
- ❖ ANY PREMISES UPON WHICH THERE EXISTS ACCUMULATION OF GARBAGE, TRASH, DEBRIS, JUNK, DEAD ORGANIC MATTER SHALL BE DEEMED TO BE AN ATTRACTIVE NUISANCE AND UNSIGHTLY. *ORDINANCE #204.2.3.9.*
- ❖ BLIGHTED OR VACANT STRUCTURES THAT INCLUDES WITHOUT LIMITATION ANY DWELLING, GARAGE, UPKEEP OF PRIVACY FENCE, OUTBUILDING OF DETERIORATION IS NO LONGER HABITABLE AS A DWELLING NOR USEFUL FOR THE PURPOSE FOR WHICH IT WAS INTENDED. ACCUMULATION OF JUNK, METALS, BUILDING MATERIAL. *ORDINANCE #204.2.*
- ❖ WOOD BOILERS PROHIBITED. METAL STRUCTURE CONSISTING OF AN ABOVE GROUND METAL CHAMBER OR FURNACE, IN WHICH WOOD IS BURNED TO HEAT WATER WHICH IS PIPED UNDERGROUND TO PROVIDE HEAT FOR A HOUSE OR BUILDING ON THE SAME PROPERTY. *ORDINANCE #205, SEC.1.*
